Data Protection

Pursuant to Art. 6 of the European Union's General Data Protection Regulation (GDPR), processing of personal data is only admissible if at least one of the conditions of Art. 6 (1) GDPR is fulfilled. Among other things, Art. 6 (1) lit a of the GDPR provides that processing shall be lawful only if the person concerned has given consent to the processing of his or her personal data for one or more specific purposes.

Purpose: The GYA collects personal data according to Art. 4 (1) of the GDPR for conducting and administering the application process.
